 - 2 firefighter/EMTs
 - 1 Fire Chief, who is also a firefighter/paramedic

>40 volunteers


 Today, this results in a fully-trained & licensed firefighter/EMT on duty daily 7 am to 5 pm.
Rely on volunteers evenings & nights

TO IMPROVE SERVICE TO OUR COMMUNITY, A REPLACEMENT FOR THE CURRENT LOCAL OPTION LEVY HAS BEEN REFERRED TO MAY 2024 BALLOT

Proposed levy rate is 97¢ per \$1,000 of assessed (not market) value, an increase of 47¢ over the current levy

If approved, the levy would support fire 8 EMS operations for next 5 years



LEVY INCREASE WOULD FUND 2 ADDITIONAL FULLY-TRAINED/LICENSED FIREFIGHTER/EMTS

- These 2 additional firefighter/EMTs would ensure at least 1 fully-trained firefighter/EMT is on duty 24 hours a day, 7 days a week
 - About 60% of calls for service happen in evening & at night when District currently relies on volunteers to respond
 - While volunteers provide vital support services, most of these individuals are not trained firefighters or EMTs (currently only 2 are trained firefighters)



>By having 24/7 coverage by fullytrained/licensed firefighter/EMTs, District will be able to:

 Reduce response times. This would occur because it will not be necessary to wait for volunteers to come from their homes or businesses to respond during evenings or nights

 Improve cardiac survival rates. Time is critical during these types of medical events. Because response times would improve, cardiac survival rates should improve



WHAT IS THE PROPOSED LEVY'S IMPACT ON MY PROPERTY TAXES?

- Depends on assessed (not market) value of property
 - Request is for 97¢ per \$1,000 of assessed value
 - For home assessed at \$218,000, about average for District, cost would be about \$211 per year or about \$17.58 a month
 - This is a \$102 per year or \$8.50 per month increase over current levy



WHAT IF LEVY DOES NOT PASS?

- >The current levy expires in 2025
- If a new levy is not approved, the District would need to reduce currently staffing from 3 to 1 firefighter/EMT
- Reliance on volunteers & mutual aid from nearby fire districts would increase, increasing time required to respond to a medical or fire emergency



IN SUMMARY...

Funds from the replacement levy would be used to provide coverage 24/7 by at least 1 fully-trained/licensed firefighter/EMT

When a fire or medical emergency occurs, the replacement levy would help ensure a West Side Fire firefighter/EMT can respond without delay
